SUPERINTENDENT KEARNS: Well, thank you all on behalf of the entire police department. We will still be around and will always support the town and Chief Farally. For the month of November, we had 78 events including 2 theft reports, 1 theft of a vehicle. We also, unfortunately had an armed robbery, we thought we would make it the whole 5 years without one, but it happened at the Dollar General during the daytime shift. We also had 3 arrests in November.

PUBLIC WORKS – P. SHURGOT: they have finished with leaves and are preparing for snow. They have decorated around the park and did normal clean up around town. There was also a second camera purchased for the dump truck.
