# BOROUGH OF WILMERDING MINUTES FROM FEBRUARY 7, 2023 WORKSHOP

- **ENGINEER B. BRANTHOOVER:** 428 Airbrake demolition began, they will be performing most of this by hand and will replace the side wall with white vinyl siding to match the rest of the buildings. Ice Plant hill problem are still being addressed. During a recent visit it was identified that the debris rack in the vault is nearly completely blocked. We notified you and were given approval to have State Pipe perform the cleaning, we will let you know a date for this work.
- S. VOLPE: are they cleaning out the lines or just that area?
- **B. BRANTHOOVER:** primarily they will just be cleaning the debris in that vault. They will continue to do some camera work and we will find out more once this is all completed.
- J. HARTZELL: I think North Versailles and East McKeesport should pay for the work, it's their debris.
- **B. BRANTHOOVER:** the low bidder for the manhole frame on Pitcairn street was Creative Enterprises and they should start the work this month. While performing the inspection for the demolition hearings we noticed that the chimney on 530 Airbrake was leaning and at risk of collapsing in the yard, Wreckcrew provided an estimate to knock this down and based on council's approval the will perform that work prior to starting 428 Airbrake. GEDTF paving was awarded in the amount of \$50,000.00. The council needs to decide how to use the funds. The trench drain will probably have to be an alternate in the bid and the Borough would have to pay for that but I will check that with COG for sure.
- J. HARTZELL: it says Bluff to Station, so we're just doing this little part?
- **B. BRANTHOOVER:** yes, just this section that is really bad. 2023 GTRP grant is open, in the past we have applied for the park rehab and will just need to know if council wishes for us to apply and for what scope.
- K. MAXWELL: I think the electrical will definitely need re-quoted.
- **B. BRANTHOOVER:** I can contact BC Electric and get a new quote if you want to keep this scope. Herman Avenue Water line repair from WPJWA will be done once the weather breaks so we will keep an eye on this process.
- J. HARTZELL: is there any word on the Duquesne Light manhole?
- B. BRANTHOOVER: I have not been able to get in touch with anyone.
- C. LANG: I was able to get in touch with someone and they were going to put a work order in for that.
- J. HARTZELL: on the invoice there are 3 different people reviewing the due diligence report, can you explain why?
- **B. BRANTHOOVER:** I will talk with them in the office and get back to you because that is not something I was involved in.

### **PETITIONS & MEMORIALS:**

**Aaron Chaney, Community Reinvestment Partners:** We are a LLC that has partnered with other towns around the county to help with the Blight. We would need someone to sponsor or be the petitioner, we would be the conservator and pay the attorney fees and set a plan of abatement, then do the necessary repairs and sell to a 3<sup>rd</sup> party. The conservator petitions the court to sell the property to the conservator then you get an appraisal and take what you spend and exchange the lien for the title or sell.

L. KIRK: are you looking at properties to do or is council giving you addresses to look at?

A.Chaney: we spoke about 1 property on Westinghouse.

J. THOMAS: what say does the council have?

A.CHANEY: what we did in Baldwin was council voted and they approved the concept and conservator.

**G. EVASHAVIK:** anyone can petition the court the take over an abandoned, blighted property, we would have to be given notice. Are you suggestion the Borough should be the Petitioner?

**A.CHANEY:** that's what was done in Baldwin with no cost to the Borough. Tax liens would be repaid at a percentage to all 3 taxing bodies.

**G. EVASHAVIK:** so your profit and expenses take priority over any Borough liens. So, you will need approval for every step of the way?

**A.CHANEY:** once the conservator is appointed the petitioner is done but can object.

K. BELIN: when you go look at a property would you give us a figure going in?

A.CHANEY: we would need to do an estimate and a final plan and we could show council those.

**S. VOLPE:** how far do you go with fixing the properties?

**A.CHANEY:** it depends, you have some areas of higher value, we would stabilize the outside of the property but as for the inside it is a case by case process.

- E. BARRETT: the goal is to sell the properties but according to our ordinance you can not sell unless the property is up to code.
- G. EVASHAVIK: that is not true, we cannot stop anyone from selling a property but we can go after them to become compliant.
- C. LANG: we do an Temp Occupancy Inspection for Sale of property that is in the sellers name so they can sell the property. Then we do another inspection for the buyer once they have obtained the property, and this is for them to reside there or rent it. This is the one that ensures the building is up to code.
