- G. JAKUB:_read letter from Chief Farally regarding the Stop sign at Ice Plant and Westinghouse Avenue.
- J. HARTZELL: there is a catch basin there and it is not feasible to rent a machine for 1 sign.
- K. MAXWELL: can we mark where it would be moved to and then decide?

BOROUGH PROPERTY – L. KIRK: Update on the hollow tree in the park, I will get a quote to take it down and have the stump ground down. We also have quotes for the work that needs to be done at the WCC. The insurance info is in the packet and the deductible for repairs is \$1000.00

L. KIRK/J. THOMAS TO PAY THE ELECTRICAL REPAIR BILL FOR \$975.00 AND NOT TURN THE CLAIM IN TO INSURANCE. MEMBERS VOTED APPROVAL, 6-0.

CODE ENFORCEMENT – AL HUSSEY: Please refer to my report.

- K. MAXWELL: do you have an update on the properties on Middle and Airbrake?
- A/ HUSSEY: I will be looking at those again on Thursday along with Mr. Filia's vacant lot.
- K. MAXWELL: if the lot is not cut by Friday can you please issue a citation to him.

PUBLIC WORKS – J. HARTZELL: everyone has a copy of the report. Please let me know if you are going to have them do something because he is telling me about stuff and I don't know what he is doing.

ENGINEER – **BRAD BRANTHOOVER:** GEDTF paving for Commerce bids will be opened on the 12th at the COG. We are applying for a bunch of grants right now. Card Avenue inlet RFP's were opened today and we received 2 bids. One came in with an error in price so I am not sure if we need to rebid this or not.

- **G. EVASHAVIK:** the bidder will need to submit a revised bid with a letter stating that there was a misprint on the original submission. You can vote now just stating that that "once the revised bid comes in"
- J. THOMAS/L. KIRK TO AWARD THE RFP FOR CARD AVENUE INLET TO CREATIVE ENTERPRISES IN THE AMOUNT OF \$7250.00 PENDING NEW SUBMISSION OF REVISION DUE TO TYPOGRAPHICAL ERROR. MEMBERS VOTED APPROVAL, 6-0.
- **B. BRANTHOOVER:** we resolved the catch basin problem on Airbrake Avenue. We had North Versailles come down and camera it and found tree roots in the line but also there is some issues inside the business as well. I also did look into the property on Patton and forwarded my findings to Caroline to pass onto council.
- **K. MAXWELL:** any update on the water situation in East McKeesport?
- **B. BRANTHOOVER:** There was a bid opening for the prelim work and there was not a single bid returned. They will have to readvertise for that. They need to camera and find out where the lines are running to basically open up the inlets along the roadway to catch more of the runoff.
- K. MAXWELL: this time it came over the wall and down the hill washing onto Westinghouse.

B. BRANTHOOVER: I am not fully involved in this project, but I will see what I can find out about it.

COG REPORT - T. SIEBLES: no meeting yet.

- **J. HARTZELL:** we have a save the date for October 18th for elected officials and fire officials talking about the reorganization of the fire department.
- **G. JAKUB:** October 10th there is a meeting with Norfolk Southern and Emergency Management for a meting to go over the safety and program that we have access to.

UTILITIES – L. BARNES: nothing to report.

SOLICITOR – G. EVASHAVIK: nothing to report.

FINANCE - J. THOMAS:

- J. THOMAS / L. BARNES TO PAY BILLS FROM THE GENERAL FUND TOTALING \$15,928.88 AND FROM THE PLGIT SEWAGE FUND TOTALING \$98,761.94. MEMBERS VOTED APPROVAL 6-0.
- **J. THOMAS:** monthly update on income for the year we have collected \$96,772.46 in RAD, \$13,731.81 in deed transfer, \$93,819.86 in EIT, \$8,661.08 in LST, \$355,183.33 in Real Estate, \$26,311.88 in Delinquent Real estate, and \$9,715.79 in delinquent garbage. Allegheny Petroleum parcel split has finally showed on the county website, and we will loose \$1600.00, neither have paid to date. I will put a list together for parcels, last year we did 9 and finally they have gone through. The CLR has finally been set at 63.5%. We hve to spend some money to get this done so I am just waiting on 1 more property to add to the list.
- **G. JAKUB:** what is the percentage of taxes that we have collected this year?
- **J. THOMAS:** to date Frank has collected about 81%, this is partially due to the non-payment of Wabtec and Allegheny Petroleum.
- **J. HARTZELL:** what is the status of billing the tenants to cover the delinquent taxes?
- **J. THOMAS:** well in our records none of them are delinquent until December 31st, we can go after the ones that Maiello has.
- **J. HARTZELL:** can't we go after them now?
- **J. THOMAS:** Caroline would be able to tell you how many of those properties are occupied but we do not know how many of them may be section 8, they are not responding to our requests for this information.

RECREATION— S. VOLPE — absent

PLANNING – T. SIEBLES– noting to report.

OLD BUSINESS:

- J. THOMAS: Did Sprague Street railings ever get completed?
- **K. MAXWELL:** yes they are done but may still need painted.
